Program of Study	Use course code from list on page 2
Enrolled Date	Date which the student begins training. Students will not receive credit for hours unless an enrollment form or electronic file is submitted to the Board by the last day of month. Newly transferred students should also use original enrollment date
Total Hours Previous Month	Total hours to date from previous month
Total Hours Current Month	Total hours accumulated for month reporting
Total Hours to Date	Combined hourly total of previous and current months
Date Discontinued	Last day of instruction
Hours Transferred	Accepted hours transferred in from another school
